Student Certification of Review and Agreement (Parent Agreement on back)

Students must accept this Agreement before they can receive a GCS Chromebook and/or use the GCS network. The GCS Chromebook the student receives will be assigned to the student to use in whichever GCS school the student is enrolled over the next few years.

- I understand that I do not own any material I may create or post on the Internet at school. Any
 information I create, transmit, or store may be inspected by an authorized GCS staff person for
 any reason without my permission or knowledge.
- Anything that I do on the Internet while at school may be monitored by a teacher or other staff member.
- I have read and understand the Digital Citizenship Rules and Unacceptable Uses of the Internet found in the GCS <u>Student Handbook</u>.
- If there was anything in the Digital Citizenship Rules or Unacceptable Uses that I found to be confusing, I asked my teacher to explain it to me and now understand it.
- I agree to follow the Digital Citizenship Rules and not to engage in any activity that is an Unacceptable Use when I use the Internet at school.
- If I do not follow the Digital Citizenship Rules or if I engage in any of the Unacceptable Uses, I
 may lose Internet access at school and my device may be taken away from me. There may also
 be disciplinary actions taken against me under the GCS Code of Student Conduct, which could
 include a suspension or expulsion from school. I may also be violating the laws of North
 Carolina or of the United States.
- I will handle and store the device safely and properly.
- I will report to the school any damage, loss or theft as soon as reasonably possible.
- I understand that not reporting damage (accidental or intentional) to a device I am using that requires repair may cause me to be fined once the damage is discovered by GCS staff.
- I have read all the information written above and understand it. I agree to follow all GCS Student Internet Use Policies.
- I agree to follow all the rules for using computers/laptops and the Internet.
