





LIFEGUARD—DEEP AND SHALLOW WATER

Responsible for the safety and well-being of all guests and employees while in the water or on an attraction with water depth up to 10ft *Shallow water depth not to exceed 4 ft. *MINIMUM AGE 16 **Certification offered FREE of charge

RIDE ATTENDANT

Responsible for the safety and well-being of all guests and employees while on a slide/attraction. Must be able to receive a shallow water license. *MINIMUM 18 **Certification offered FREE of charge

ADMISSIONS/GREETER

Responsible for greeting customers, handling cash transactions at the main gate, season pass building, and parking toll booths. *MINIMUM AGE 16

FOOD SERVICE COOK/PREP

Responsible for preparing, cooking, and storing all food products. *MINIMUM AGE 15

FOOD SERVICE CASHIER/CABANA WAIT STAFF

Responsible for handling cash transactions and food flow to guests at their assigned location. Cabana wait staff will be responsible for servicing private cabana rentals. Server/bartender experienced preferred for cabana staff. *MINIMUM AGE 15 **CABANA STAFF MUST BE 18

CUSTODIAL AND MORNING/NIGHT CREW

Responsible for cleaning and maintaining all restrooms and bath houses.

Morning/night crew is responsible for all of the pre-opening and post-closing cleaning of the park including pressure washing, landscaping, painting, etc. *MINIMUM AGE 16

GROUNDS, PARKING, TUBE ATTENDANT

Responsible for the cleanliness and overall appearance of the park.

Parking/tube attendant will be responsible for directing cars in the most efficient manner, as well as cleaning and repairing tubes and furniture within the park. *MINUMUM AGE 15

GIFT SHOP/RENTALS

Responsible for cash transactions and restocking items at their assigned area. Guest assistance with cabanas, lockers, strollers, wheelchairs, and park information. *MINIMUM AGE 16

BAG CHECK/TICKET TAKER

Responsible for greeting guests at entry while ensuring a safe and secure environment within the park. *MINIMUM AGE 15

OFFICE ASSISTANT/CASH CONTROL

Responsible for the daily operation of the main office: Employee/HR, guest, and vendor relations. Cash Control is responsible for the day-to-day handling of sales generated throughout the park. *MINIMUM AGE 18

AQUATECH/MAINTENANCE

Responsible for maintaining water quality, chemistry, and pool cleanliness. *MINIMUM AGE 16

FIRST AID—EMT

Responsible for the care and well-being of all customers and employees. Must have current EMT-B or higher, and currently active in an agency. *MINIMUM AGE 18

PARK DISPATCH

Responsible for answering all in-park calls, radio traffic, and handling emergency communications. Also responsible for in-park announcements. *MINIMUM AGE 16
