



PK-12 Historical and Projected Enrollment












Morehead Elementary School – Dashboard




Scoring Data –Building Condition



Scoring Data –Education Suitability




Scoring Data –Technology Infrastructure






Scoring Data –Combination Scores






Previous District / County Facility Financial Information DRAFT

- On May 6, 2008, Guilford County (County) residents approved \$412 million in school bonds.
- The package contained 27 projects, which include five new schools.
- 6,571 new student seats. Thirteen schools will receive major renovations and additions.
- Projects included in the bond are prioritized with 93.5 percent of the request relieving overcrowding.
- 3.5 percent targeting repairs and renovations.
- 3 percent improving heating and air conditioning systems district wide.
