## For Alternate Assessments (Excluding Read to Achieve):

With the exception of the **Read to Achieve Alternate Assessment**, participation in the above named alternate assessments is based upon eligibility requirements provided by the NCDPI. Additionally, the student must have an Individual Education Program (IEP) that documents participation in the state approved alternate assessment.

## For Read to Achieve:

The **Read to Achieve Alternate Assessment** serves as an alternate proficiency measure for Grade 3. The assessment is administered to any student who has failed to meet the Grade 3 reading proficiency standards required by our state legislatures in the *Read to Achieve* legislative initiative.
