Yesterday, Guilford County Schools announced the lift of the mask mandate across the school district.

Please note, however, that Greensboro College Middle College, which is located on the campus of Greensboro College, is, as such, required to adhere to the college campus masking requirements. The masking requirement is set forth below and available on the Greensboro College website.

## All students and staff of Greensboro College Middle College are required to wear masks daily in accordance with the requirements and that remains in place.

Please encourage your student to continue adhering to the policy. Please contact our office with any questions.

## Greensboro College Masking Guidelines:

- Wearing of masks is required indoors in all campus buildings except while eating, or alone in the dorm rooms regardless of vaccination status. This includes all guests to the campus.
- In residence halls, masks are required in hallways. Residents may have up to **two** guests in their rooms and we highly encourage all to be masked if some are not vaccinated.
- Masks are not required outdoors except in large gatherings of 200 or more.
- Prospective students on tours may sit in on a class if masked. They are required already to be masked at all times indoors, but may remove masks while outdoors on the tour.
- If theatre performers are vaccinated, they may perform onstage unmasked, however, audiences will still be required to wear masks.

## Health and Safety of the Campus Community

All of us – students, faculty and staff – must do our part to keep each other healthy to have a successful on-campus semester. Educational conversations will be key for all members of the community as we work to take care of one another and hold each other accountable.

- The college no longer requires 6-feet social distance spacing in classrooms and common areas.
- The college has developed contact-tracing protocol for students and employees, using Health Department recommendations.

- Wall-mounted, hands-free thermometers have been installed throughout campus, in hallways and other spaces within our buildings. They are automated so that the user can just walk up to it, lean in and point their forehead to the front sensor for a reading.
- Visitors to Campus: The campus is open to all visitors though the college requires that they be masked inside all buildings.
- The college requires GC students to submit proof of vaccination, a negative COVID-19 test within 96 hours or positive test within 90 days. Everyone must submit prior to their official check-in date with the College. Traditional students and/or athletes upload their tests through Magnus, and all other students may submit proof through covidquestions@greensboro.edu. Unvaccinated students will be subject to random testing by Student Health and the Athletic Trainers throughout the year to monitor COVID-19 spread on campus.
