

















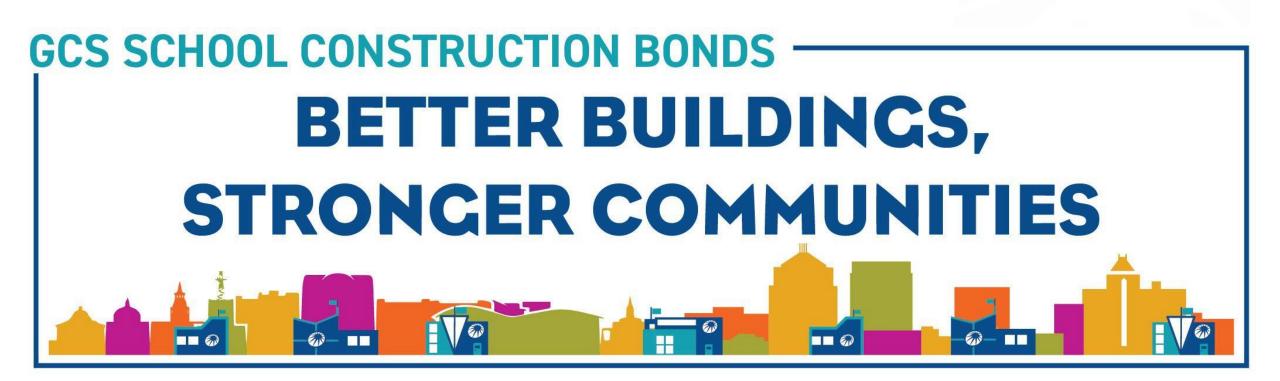

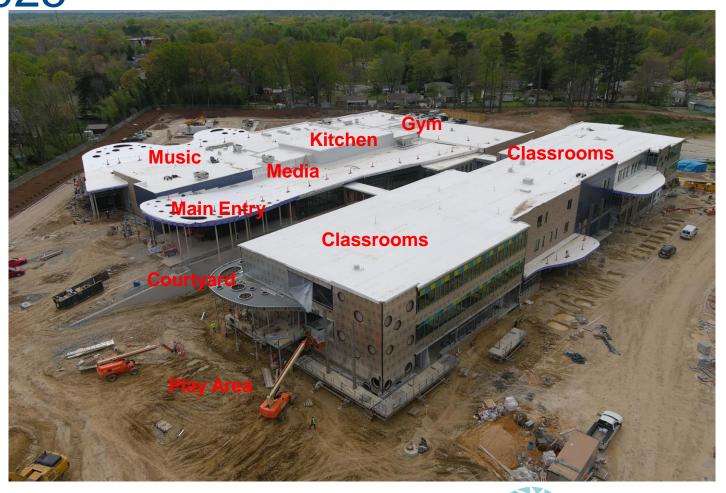

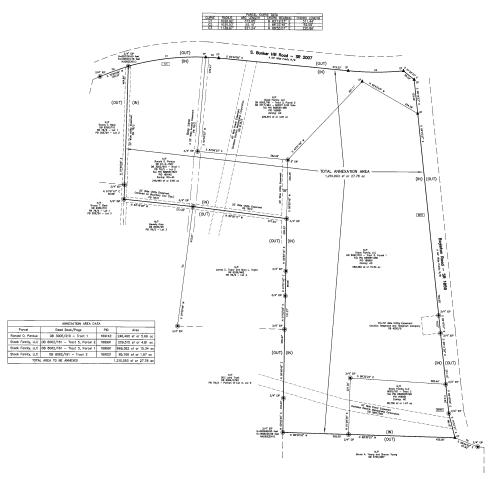


Katherine G. Johnson K-8 – Occupancy August 2026
