#### **JOB TITLE: DIRECTOR I - STEM**

#### GENERAL STATEMENT OF JOB

Under limited supervision, performs a variety of supervisory and administrative tasks in overseeing the successful implementation of STEM curriculum and instructional practices. Employee is responsible for providing leadership in the development, implementation, and evaluation of STEM programming to promote student learning and teacher effectiveness for the benefit of the system's total educational program. Responsible for providing district-wide leadership in PK-12 STEM curriculum, instruction, and intervention. The individual is responsible for leading the STEM department in identifying and implementing opportunities to increase the quality of the district's STEM program and career pathways for students. Reports to the Assistant Superintendent of Teaching, Learning, and Professional Development.

## SPECIFIC DUTIES AND RESPONSIBLITIES

## **ESSENTIAL JOB FUNCTIONS**

Leads STEM Department in improving techniques of STEM instruction and improving overall student achievement.

Works collaboratively with other departments and higher education partners to create STEM pathways and opportunities for students in the area of Science, Technology, Engineering, and Math.

Communicates clear expectations and goals for the work of the STEM Department.

Manages a high functioning team that is able to execute effectively and meet deadlines.

Directs the key activities within the STEM Department.

Facilitates and coordinates key activities across departments and other organizational units.

Directs the implementation of curriculum and instructional strategies that create a clear pathway for success for all students.

Works in conjunction with other district departments to facilitate and support STEM development and implementation across all departments.

#### ADDITIONAL JOB FUNCTIONS

Provides guidance and leadership in the development of STEM conferences, district Science/STEM Fair, workshops, research and publications projects, consultation, and support for STEM meetings and projects; provides personal leadership to most important initiatives.

Facilitates and manages the comprehensive STEM strategy that includes vendor supplier development.

Develops an annual STEM report for Board of Education, Superintendent, and the public.

Other duties and responsibilities may be assigned as appropriate by the Assistant Superintendent of Teaching, Learning, and Professional Development and Chief Academic Officer.

Performs other related work as required.

## MINIMUM TRAINING AND EXPERIENCE

Master's Degree in STEM field with extensive course work in education, and 5 to 7 years of teaching experience with program coordination experience; or any equivalent combination of training and experience which provides the required knowledge, skills and abilities.

#### **SPECIAL REQUIREMENTS**

Must be certified to teach in the State of North Carolina. Must possess a valid North Carolina Driver's License.

# MINIMUM QUALIFICATIONS OR STANDARDS REQUIRED TO PERFORM ESSENTIAL JOB FUNCTIONS

<u>Physical Requirements</u>: Must be physically able to operate a variety of equipment including computers, overhead projectors, typewriters, copiers, facsimile machines, calculators, protractors, compasses, etc. Must be physically able to operate a motor vehicle. Must be able to exert up to 10 pounds of force occasionally, and/or a negligible amount of force constantly to lift, carry, push, and pull or otherwise move objects, including the human body

Light work usually requires walking or standing to a significant degree.

<u>Data Conception</u>: Requires the ability to compare and/or judge the readily observable, functional, structural or composite characteristics (whether similar or divergent from obvious standards) of data, people or things.

#### **DIRECTOR I - STEM**

<u>Interpersonal Communication</u>: Requires the ability to speak and/or signal people to convey or exchange information. Includes giving instructions, assignments or directions to subordinates or assistants.

<u>Language Ability</u>: Requires the ability to read a variety of correspondence, reports, forms, applications, purchase orders, test results, etc. Requires the ability to prepare correspondence, reports, presentations, newspaper articles, requisitions, forms, evaluations, budgets, etc., using prescribed formats and conforming to all rules of punctuation, grammar, diction, and style. Requires the ability to speak before groups of people with poise, voice control and confidence.

<u>Intelligence</u>: Requires the ability to apply principles of logical or scientific thinking to define problems, collect data, establish facts, and draw valid conclusions; to interpret an extensive variety of technical instructions in mathematical or diagrammatic form; and to deal with several abstract and concrete variables.

<u>Verbal Aptitude</u>: Requires the ability to record and deliver information, to explain procedures, to follow oral and written instructions. Must be able to communicate effectively and efficiently in standard English.

<u>Form/Spatial Aptitude</u>: Requires the ability to inspect items for proper length, width and shape.

<u>Motor Coordination</u>: Requires the ability to coordinate hands and eyes rapidly and accurately in using office equipment.

<u>Manual Dexterity</u>: Requires the ability to handle a variety of items such as office equipment and hand tools. Must have minimal levels of eye/hand/foot coordination.

<u>Color Discrimination</u>: Does not require the ability to differentiate between colors and shades of color.

<u>Interpersonal Temperament</u>: Requires the ability to deal with people beyond giving and receiving instructions. Must be adaptable to performing under stress and when confronted with emergency situations.

**Physical Communication:** Requires the ability to talk and hear: (Talking: expressing or exchanging ideas by means of spoken words. Hearing: perceiving nature of sounds by ear.) Must be able to communicate via telephone.

#### KNOWLEDGE, SKILLS AND ABILITIES

Thorough knowledge of the North Carolina Standard Course of Study as it applies to STEM standards.

#### **DIRECTOR I - STEM**

Considerable knowledge of the current literature, trends, and developments in the field of STEM instruction.

Knowledge of basic computer technology: Microsoft Office.

Considerable knowledge of the principles of supervision, organization and administration.

General knowledge of the County and School Board policies, procedures and standards regarding reading education.

General knowledge of the organization and communication channels of the school system.

General knowledge of the ethical guidelines applicable to the position as outlined by professional organizations and/or federal, state and local laws, rules and regulations.

General knowledge of the grant application and administration process.

Skill in counseling and developing staff.

Ability to review and evaluate testing results and to develop a plan of action based on conclusions.

Ability to select appropriate and effective reading textbooks and other materials.

Ability to develop innovative and effective STEM instructional materials.

Ability to use common office machines and popular computer-driven word processing, spreadsheet and file maintenance programs.

Ability to maintain complete and accurate records and statistics and to develop meaningful reports from that information.

Ability to develop meaningful annual budgets.

Ability to effectively express ideas orally and in writing.

Ability to make effective oral presentations before large groups of people.

Ability to exercise considerable tact and courtesy in frequent contact with the public.

Ability to establish and maintain effective working relationships as necessitated by work assignments.
